God has said this, Jeremiah 29:11 For I know the plans I have for you," declares the LORD, "plans to prosper you and not to harm you, plans to give you hope and a future.
- 3. Know the difference between right and wrong, light and darkness. As we walk on our journey, what we do is because of who we are, not just trying to follow a set of rules. Not walking in the light because we will be caught but because the light of Christ is within us. Our choice of right is because we are caught up in the light. That is who <u>you</u> are!
- 4. Awareness of connectedness during our journey makes us discover we are people together. The light that is in me is somehow connected to the light that is within you. The light in all of us somehow comes together and is connected to the great light of Christ. If the little things in life are important to you, then they are important to others as well. There are thousands of invitations to the light of Christ around us. From the Congregation Council:October 2024 meeting

- Received a letter from Faith Circle requesting Epiphany to send \$1000.00 from the "Faith Circle Fund" to one of the North Carolina churches affected by the hurricane. This was approved. The 2024 budget has funds set aside for outreach to NALC congregation and that money will also be sent with the money appointed by Faith Circle.
- The treasurer presented the 2025 congregation budget. After much discussion the budget was approved to come before the congregation at the meeting scheduled for December 1, 2024.
- An update for the permits, construction, and loan were discussed. The property committee has all the documents in for county approval. Now we await their feedback from each of the divisions. The contractors are ready to start, and they are working with the county to make changes to begin the building of our worship center. We have spoken to our bank, and they have asked for a few items before giving Epiphany the construction loan. Those items are being worked out and we will meet for congregation approval prior to signing any loan documents.
- The property purchase approved by the congregation in September 2024, is scheduled to close on October 25, 2024. This small .08 acres will allow the garage to meet county setback requirements. This also allows us to convert the building from storage into classrooms and a sacristy for the church.
- The council discussed in length the \$100,000.00 dollars owed to Epiphany from St. Paul. At this point, the judge has not received the orders for her to sign. She will not receive the draft order to sign until both attorneys can agree on the substance within the order. Our draft was sent to the minority attorney already. We await the draft order from St. Paul, that reflects the judge's ruling. We cannot give you a time when this will take place.

BEWARE OF THE LATEST FROM THE ELCA'S COMMISSION FOR A RENEWED LUTHERAN CHURCH

As promised, we continue to monitor the work of the ELCA's Commission for a Renewed Lutheran Church (CRLC). That Commission was formed in response to action taken by the ELCA's 2022 Churchwide Assembly, which directed the Church Council to establish a Commission that shall "reconsider the statements of purpose for each of the expressions of this church, the principles of its organizational structure, and all matters pertaining thereunto." The Commission was instructed to be "particularly attentive to our shared commitment to dismantle racism" and to "present its findings and recommendations to the 2025 Churchwide Assembly in preparation for a possible reconstituting convention."

A written summary of the Commission's seventh meeting – held from August 8-10 – can now be found on their website. A link to that website can be found **HERE** - Commission for a Renewed Lutheran Church - Evangelical Lutheran Church in America (elca.org). There are several items in that written summary that I believe should cause great concern.

Fourth bullet point under August 8 –

The CRLC received updates from the Church Council and a subcommittee on the progress of the DEIA (Diversity, Equity, Inclusion, and Accessibility) audit.

The ELCA continues full speed ahead with the DEIA audit. Please see my article, "A Warning of What Is Coming," in the March 2024 issue of our newsletter, where I list several of the expectations of congregations from that audit. A link to that article can be found **HERE -** A Warning of What is Coming - Lutheran Coalition for Renewal (CORE) (lutherancore.website). In that article I raised the question of whether and how congregations will be penalized if they are not DEIA compliant. I also asked pastors and church leaders to consider how the ministry and mission priorities of their congregation will be derailed and the energy of their congregation will be consumed by efforts to become DEIA compliant. If you do not believe what I said in the article, just look at the Minimum DEIA Standards for Congregations and the changes in the Model Constitution for Congregations as recommended by the law firm that did the audit. Some people have said that they see DEIA as very compatible with the Gospel. My response is that it is the exact opposite of the Gospel. DEIA is legalism at its worst and pure Marxism. Its demands are insatiable, it can never offer forgiveness, and it cannot provide deliverance. No matter how much you repent of and grovel because of your own oppressive behavior as well as the oppressive behavior of your ancestors and others of your race, it is never enough. You cannot do enough. You will always fall short. You cannot be forgiven, because if you are forgiven, then those who claim that you are oppressing them lose their power over you. And it cannot provide deliverance. If you are white, male, straight, and/or a member of any of the other privileged, oppressive people groups, then you cannot not be an oppressor. Rather the systems that privilege and empower you must be dismantled.

An Interview with First Fruits Farm Owners' Pete and Suzanne Morgan

Interviewer: When did you acquire First Fruits Farm? Why?

Suzanne: We bought the farm in 2022. We were interested in starting our own hydroponics farm in order to be more self-sufficient. The man I was buying my blueberries and tomatoes from owned a hydroponics farm. When I went one day to buy my blueberries, he mentioned to me that he was selling his farm. So I told him we would buy it. He helped us start it. He stayed on and taught us. He mentored us through it all and he's still a phone call away if we have questions or need help. He left everything for us. He left everything in place.

Interviewer: How did you choose the name, First Fruits Farm?

Suzanne: We give our first fruits to God, and we wanted this place to help us and to serve others. We want to share our fruits with others and share this farm.

Interviewer: Did the Chickens come with the farm? What made you decide to buy chickens?

Suzanne: No. It was originally just the berry farm. We just decided to get chickens and raise our own eggs. We're trying to be more self-sustaining.

Interviewer: Did you plan to sell the eggs at the church when you bought the chickens?

Suzanne: No. not at first. Later, we thought it was a great way to raise money for the church. We're going to sell the eggs so we might as well sell them to the congregation and raise money for the building fund.

Interviewer: How many chickens do you have?

Suzanne: Twenty-seven. Two roosters and the rest are hens.

Interviewer: What is involved in caring for the chickens?

Pete: Well, everyday it takes about half an hour to collect eggs and feed them. We also have to clean out the chicken coup every so often, sometimes we have to mix feed, go get the feed, change their water. Every couple weeks I clean out the water buckets. They get fresh water every day when they get feed.

Interviewer: What do you feed the chickens?

Suzanne: We feed them top grade, non-gmo chicken feed. It has no additives. It's all natural. Then we do give them treats like bread, pumpkins. They love pumpkins. They love fruit. They love watermelon. We also give them a dish of crushed oyster shells. It help keeps the eggshells sturdy.

Interviewer: Do the chickens lay eggs every day?

Pete: Yes, they do. But not all chickens lay every day.

Interviewer: Do you wash the eggs after you collect them?

Pete: We do not. And the reason we don't is because it has a coating on it when the chickens lay them. Actually, I gave you that article. (referenced article can be found after this interview). The coating prevents bacteria from getting into the eggs. If you wash it off, eggs tend to be porous, and water can get into the eggs. As long as you keep them unwashed, you can keep them for several weeks outside and not using them. In that article, it goes back to before refrigeration and people never refrigerated their eggs. In fact, the United States is probably one of the only countries that washes eggs and puts them in the refrigerator in the processing. The factory eggs are like that. These home-grown eggs are fresh eggs and as long as people don't wash the coating off it's fine.

Interviewer: When people get the eggs from you, should they wash them or just leave them out?

Pete: It's up to them. If they're going to wash them then they should put them in the refrigerator. They'll keep for a long time just left out. They'll keep for a month to a couple of months easy.

Interviewer: So they can wash them but they'll have to put them in the fridge?

Pete: Yes. And make sure it's clean water. Wash them under the sink. You don't want to wash them all in a bowl of water. Use running water.

Interviewer: What makes farm raised eggs better than store bought eggs?

Suzanne: They're fresh every day!

Pete: They're fresh. Chickens tend to be happier....you have a happy chicken you get more eggs and the chickens are healthier. We let them out in the chicken run and let them run around. The other thing is what we feed them. It's non-gmo feed and we give them extra calcium. It's a high protein feed. It gives the eggs a much richer yoke. If you look at our eggs versus a store-bought egg, their egg is not the deep yellow that ours are. Ours are a richer egg.

Interviewer: What else do you have at the farm?

Suzanne: Well, we have grapevines, Muscadines, Scuppernongs . We have blackberries, blueberries. We have peach trees, pear trees, figs, and we grow in the greenhouse, the tomatoes, peppers. That's grown inside by hydroponics. Outside we plant cabbage, okra. And we're beginning to venture out and wanting to plant more stuff.

Interviewer: What does hydroponics mean?

Pete: It's growing vegetables, primarily in this case, not using soil; just using nutrient water. There's several methods to do it. We use the bucket method when I use the nutrient mix that I make, and we use five-gallon food grade buckets.

Interviewer: What is your long-term goal for the farm?

Pete: Mass production. *laughs.* To enhance production. To tend to it on an everyday basis. We don't have as much time to tend to it right now. And by doing that we can maybe do different varieties. This year I want to start earlier coming up in 2025. I want to start the seeds here (in the cottage) in January in the seed pods and get them started and transfer them to the greenhouses in February. The hope is to have really good tomatoes in the March and April time frame when it isn't too hot. We'll also start the cucumbers and cabbage. Cabbage likes chillier weather. We're learning and we probably have been starting the cabbage a little too late so that by the time it's ready to come on the bugs are getting it. We need to start growing cabbage maybe in November and have a winter cabbage. Ultimately, I want to, if I can back out of the businesses, I want to grow okra, watermelon, and some pumpkins. So yes, the goal is to produce more and share more. The more I can produce the more I can share.



Why Americans Refrigerate Eggs

Being raised in the United States, I was startled during my first trip out of the country. I noticed that the eggs at the store were not refrigerated. How is this possible? I assumed it had something to do with being uncivilized and poor, because, of course, people often assume that the ways of one's own country are the only right ways.

As my travels increased, I noticed it again and again. I gradually came to realize that the United States is the outlier, apparently the only country in the world where eggs go from the chicken to the refrigerator, both at the store and at home. People assume that they would otherwise spoil.

How, then, is it possible that people aren't getting sick and dying from rotten eggs all over Europe, Latin America, and the Far East? People all over the world have eaten eggs without refrigeration. For that matter, refrigerators only became commonplace in U.S. homes in the middle of the 20th century. How is this possible?

I once visited a recreated general store from the 1920s, and it had a jar of pickled eggs. My assumption then was that this is how people managed to keep eggs past the laying. They soaked them in vinegar and that kept them fresh.

Well, all of this is bullocks. The United States seems to be the only country in the world that requires the washing of eggs before they are sold. As a result, the outside membrane—called the cuticle—is washed away, leaving them vulnerable to outside bacteria and other sources of spoilage. That's why they must be refrigerated.

Once refrigerated, they can't sit on the counter. The U.S. Department of Agriculture (USDA) explains: "After eggs are refrigerated, they need to stay that way. A cold egg left out at room temperature can sweat, facilitating the movement of bacteria into the egg and increasing the growth of bacteria. Refrigerated eggs should not be left out more than 2 hours."

However, if you don't wash away the cuticle, they can sit happily on the counter for a very long time and be ready to eat anytime.

The USDA is perfectly correct on this point too: "It's not necessary or recommended for consumers to wash eggs and may actually increase the risk of contamination because the wash water can be 'sucked' into the egg through the pores in the shell. When the chicken lays the egg, a protective coating is put on the outside by the hen."

I wondered if the Americans did this because of our love of new technology, which is a feature of our culture dating back to the earliest days of the Republic. We have infinite confidence in progress, based on our experiences with every growing standard of living. We like to use our gizmos and adapt our lives around them. We do this with digital things now, imposing scans and apps even when they are wholly unnecessary. Maybe the same thing happened with eggs?

That turns out not to be true in this case. The rule that you can't sell eggs without first washing them, even on a farm, comes directly from the USDA. The USDA is perfectly clear: "Government regulations require that USDA-graded eggs be carefully washed and sanitized using only compounds meeting FDA [U.S. Food and Drug Administration] regulations for processing foods."

Again, apparently the only country in the world where this is true!

Maybe this practice traces to the American obsession with cleanliness. We shower more than anyone else. We wash our hair incessantly. When it was announced that we all have to stay away from each other to get away from the bad new virus, most Americans readily complied. This comes down to the (faulty) view that all bad pathogens are external and the key to health is keeping them as far away as possible.

As it turns out, that isn't the reason either, though many people never question the rule for this precise reason.

The actual reason was explained to me by a lady at one of the surviving local farms that raises its own vegetables and tends to livestock for meat. She also sells fresh eggs, but only from the refrigerator. Why are they refrigerated, I asked?

She explained with some anger that she's required by the USDA to wash them. This makes no sense, she said, because her eggs aren't dirty. The chickens roam freely, they are happy and spaced out in their coops, and the eggs they lay are beautiful, clean, and ready to eat. She doesn't like washing off the cuticle, but she has to in any case.

As for her own personal chickens and eggs, she never washes them and leaves them on the counter. However, she is not allowed to sell those. She can give them away to friends and family but not sell them to the general public. I kept probing. What is the reason for this? She put it plainly. It's because of Big Agriculture and industrial methods of egg harvesting. They pack chickens in huge warehouses inches apart and in tight layers. The whole place is a gigantic mess because machines can't stop the natural function of the digestive system. In essence, the place is filthy. As a result, washing the eggs is absolutely necessary to remove all the pathogenic muck.

The industry, then, lobbied the government over decades to make this a general rule, providing them with a level competitive playing field with small farmers who run much cleaner operations. This way everyone has to wash their eggs and all eggs for sale have to be put into the refrigerator immediately, because without the cuticle, they are vulnerable to infection.

Having explained all this, she ended with a final cry of fury: "My chickens are not dirty and neither are their eggs!"

What about the bird flu? She said she has never seen any evidence of this bird flu in her flock. She can easily imagine, however, that industrialized methods would make chickens vulnerable to every manner of infection. But why should small farmers be forced to take precautions against a danger that mainly affects heavily subsidized industrial farms? She quickly added that her farm gets no subsidies at all, and is barely surviving.

In effect, the USDA and the FDA have adopted rules on behalf of the biggest players in the industry while forgetting about the small farmers. I'm far from being an expert on this topic, but everywhere I look, I find agency-generated rules rather than legislation from Congress.

And so one wonders what happens now that the Supreme Court has clearly said that agencies can't simply pass their own rules without a legislative mandate on the particulars. This momentous decision is called *Loper Bright* [Loper Bright Enterprises et al. v. Raimondo] and it repudiates the previous rule of Chevron deference. One wonders if, finally, small farmers have a fighting chance now.

Maybe in the future, Americans will have the right to raise and sell eggs without washing off the protective layer from the shells. Maybe in the future, we will stop being seemingly the one outlying country in the entire world that routinely refrigerates our chicken eggs? We shall see.
